Subject: **MINUTES OF MEETING HELD IN THE DIRECTORATE (ADMN/MVR), EXCISE, TAXATION & NARCOTICS CONTROL KARACHI ON 01.11.2019 AT 11:00 PM TO DISCUSS THE REPORT OF TECHNICAL COMMITTEE REGARDING EVALUATION OF TECHNICAL PROPOSALS SUBMITTED BY M/S MOHSIN ENTERPRISES, SHAHEER TRADERS, WAQAS ENTERPRISES, TRADE ZONE INT'L, MULTIBUSINESS CORPORATION, M. SIDDIQUE & CO., BUSINESS LINKS & TRADE AND IS ENTERPRISES FOR SUPPLY OF UNIFORMS & PROTECTIVE CLOTHING**

A meeting to discuss the report furnished by the Technical Committee was held in this Directorate on **01.11.2019 at 11:00** under the chairmanship of the Director (ADMN/MVR), Excise, Taxation & Narcotics Control, Karachi/Chairman Procurement Committee and was attended by all the five members (attendance sheet enclosed), as well as representatives of all the participating bidders viz: M/s **1. Mohsin Enterprises, 2. Shaheer Traders, 3. Waqas Enterprises, 4. Trade Zone Int'l, 5. Multi business Corporation, 6. M. Siddique & Co., 7. Business Links & Trade & 8. IS Enterprises.**

The meeting started with the recitation of Holy Quran. The Chair informed that the Deputy Director (HQ), Directorate General (Excise & Taxation) has been proceeded on Ex-Pakistan Leave, hence, will not attend the meeting. The chair welcomed the participants and apprised the significance of the meeting. Later, the chair asked the Chairman Technical Committee to read the report aloud and answer queries thereof, if any.

The Technical Evaluation Report was opened in front of the Procurement Committee members as well as the participating bidders which was sent by the Chairman Technical Committee vide letter No. **DD/MR-ADMN/ESTT/3031** dated 24.10.2019; the Chairman Technical Committee started reading the report on point to point basis by comparing the rates as well as gauging the quality of material provided by the bidders as per criteria laid down in the RFP/bidding document and as per the criteria laid down in the Sindh Public Procurement Regulatory Authority, Rules 2010 (amended 2019).

It was informed that the proposals submitted by M/s **Mohsin Enterprises, Shaheer Traders, Multi business Corporation** and **Trade Zone Int'l** were rejected on technical grounds mentioned below:

FIRM

REASONS FOR REJECTION/DISQUALIFICATION

M/s Mohsin Enterprises

Quoted price of sandals but not provided the samples, as required in the Financial Price Schedule in description of items/goods/services at serial number 6 of RFP/bidding document; without samples of sandals the quality of complete kit cannot be ascertained. Therefore, the Technical Committee recommended that M/s Mohsin Enterprises may not be considered for further tendering process.

M/s Shaheer Traders

Quoted price of sandals but not provided the samples, as required in the Financial Price Schedule in description of items/goods/services at serial number 6 of RFP/bidding document; without the samples of sandals the quality of complete kit cannot be ascertained. Therefore, the Technical Committee recommended that M/s Shaheer Traders may not be considered for further tendering process.

M/s Multi-business Corporation

The firm has furnished an affidavit on Rs. 50/- stamp paper instead of Rs. 100/- stamp paper as required vide Section - III (Qualification & Evaluation Criteria) ITB Clause 16 (D) of the RFP/bidding



document, which states that:

"An undertaking on stamp paper of Rs. **100/-** by the firm/contractor to the effect that "Neither the firm/contractor nor its Directors/stakeholders as a whole or as a part of the company/organization", have ever been blacklisted/defaulted with any Government Agency/Department/ Organization and also that the information supplied by the firm/contractor is correct."

M/s Trade Zone Int'l


The firm has not attached the professional tax details in the bids required vide clause "C" of the terms and conditions of Notice Inviting Tender published in daily newspapers, which is reproduced as under:

"C. All required documents i.e. GST, Income Tax (FBR), Professional Tax Certificate must be attached along with Technical Proposal for Tender."

It was further informed that the bids submitted by the following four firms were found complete in all respects and consolidated statement of rates so quoted are appended against each bidder:

As M/s **M. Siddique & Co.** being the first (1st) lowest priced bidder substantially responsive to all requirements of bidding documents



having offered rates of **Rs. 2,442,000**(i.e. Rs 5,550/- per kit including all items) **for 440 kits** and the quality of uniform and liveries was also comparatively better than the other short listed participants i.e. Waqas Enterprises, Business Links & Trade and IS Enterprises, hence, **M/s M. Siddique & Co.** was recommended for further bidding process.

The Procurement Committee unanimously praised and agreed with the findings and recommendations of the Technical Committee and it was unanimously decided that the Bid Evaluation Report shall be hosted at PPMS/SPPRA website as termed mandatory before award of tender by the Competent Authority.

The meeting ended with a vote of thanks to and from the chair.

First (01st) meeting of the Technical Committee constituted vide letter No. DVR/MR(43)/Procurement/NP-TTS-U/2019-20/**1423** dated 27.08.2019 (Copy enclosed at Annexure "A") was convened on 10.10.2019 at 03:30 PM in the Directorate (ADMN/MVR), Excise, Taxation & Narcotics Control, Karachi vide No. DD/MR-ADMN/ESTT/2534 dated 09.10.2019 (copy enclosed at Annexure "B") and was attended by all the members (attendance sheet enclosed at Annexure "C").

The meeting started with the recitation of Holy Quran. The members were informed that the Chairman Procurement Committee sent the technical as well as financial proposals along with samples of Uniform kits vide Letter No.DVR/MR(43)/Procurement/NP-TTS-U-2019-20/**1731** dated 08.10.2019 (copy enclosed as Annexure "D") submitted by **M/s (1) Mohsin Enterprises, (2) Shaheer Traders, (3) Waqas Enterprises, (4) Trade Zone Int'l, (5) Multibusiness Corporation, (6) M. Siddique & Co., (7) Business Links & Trade and (8) IS Enterprises** for evaluation of technical as well as financial Proposals as per evaluation criteria laid down in the RFP/bidding document . The bids submitted by **M/s Multibusiness Corporation, Trade Zone Int'l, Mohsin Enterprises and Shaheer Traders** were rejected and disqualified on technical grounds mentioned below:

 **M/s Multibusiness Corporation** has furnished an affidavit on Rs. 50/- stamp paper instead of Rs. 100 stamp paper as required vide Section - III (Qualification & Evaluation Criteria) ITB Clause 16 (D) of the RFP/bidding document, which is reproduced as under:

 "An undertaking on stamp paper of Rs. 100/- by the firm/contractor to the effect that "Neither the firm/contractor nor its Directors/stakeholders as a whole or as a part of the company/organization", have ever been blacklisted/ defaulted with any Government Agency/Department/Organization and also that the information supplied by the firm/contractor is correct."

M/s Trade Zone Int'l has not attached professional tax details in the bid as required vide clause "C" of the terms of conditions of Notice Inviting Tender published in daily newspapers, which is reproduced as under:

"C. All required documents i.e. GST, Income Tax (FBR), Professional Tax Certificate must be attached along with Technical Proposal for Tender."

Further, **M/s Mohsin Enterprises and Shaheer Traders** have though quoted the price of sandals but not provided the samples, as required in the Financial Price Schedule in description of items/goods/services at serial number 06 of RFP/bidding document. As without the samples, the complete kit quality cannot be ascertained, so, the Technical Committee unanimously decided that both the firms i.e. **M/s Mohsin Enterprises and Shaheer Traders** may not be considered for further tendering process.

Following the parameters in the evaluation criteria for the bidders as described in the Bidding Document/RFP, the bidding documents were scrutinized in detail by all the members of the Technical Committee and a consolidated statement is appended as under;
