Furtherance to the Meeting held on 02nd March, 2020, the Second meeting for Supply of Uniforms and Protective Clothing Items for the year 2019-20 was held under the Chairmanship of Additional Secretary (Admin-I) on 02nd April, 2020 at 02:00 P.M in his office. (The list of participants attached).

The Meeting started with the recitation from Holy Quran. Thereafter, in opening remarks, the chair welcomed the participants and opened the forum for discussion. The Draft Bidding Document was presented and reviewed in the light of decisions taken in the last meeting held on 02nd March, 2020, and the relevant points were also included in the Draft Bidding Document accordingly.

In the light of SPPRA Rules 11 (a) (b) and SPPRA Rule 46 (1) (a) (b) (c), the Procurement Committee decided the Preliminary (Mandatory) Screening Criteria for selection of Bidder(s) at Preliminary Stage Bid(s) and those who will not pass this stage will be disqualified as Non-Responsive Bid(s) and will be rejected from Tender Process at initial stage. For this purpose the Bidder(s) shall be advised to provide the requirements as given in the Tender Bidding Document. Furthermore, the Notice Inviting Tender (NIT), Qualification and Evaluation Criteria were also finalized by the Procurement Committee in the meeting.

After detailed discussion, following was unanimously decided:-

1. All the points noted in the earlier meeting are included in the Draft Bidding Document.
2. Notice Inviting Tender (NIT) for publication was finalized the same are included in the Draft Bidding Document.
3. Preliminary (Mandatory) Screening Criteria, Qualification and Evaluation Criteria were also finalized; the same are included in the Draft Bidding Document.

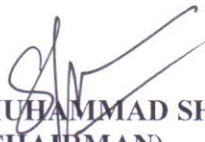
