2. Functions and Responsibilities of Procurement Committee shall be as under:-

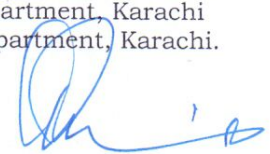
- i) Preparing bidding documents.
