Bids will be opened by the purchase committee in the presence of bidder's or authorized representatives of bidders on 15<sup>h</sup> April 2024 02:00 pm in the office of Directorate General (Excise & Taxation) Excise, Taxation & Narcotics Control, Karachi DG's Complex beside Jung Building I.I Chundrigar Road Karachi
- 7. In case of a holiday the bid will be obtained/submitted/opened the next working day at 01:00 p.m. and opened same day at 02:00 p.m.
- 8. Excise, Taxation and Narcotics Control Department, Government of Sindh reserves the right in accordance of Sindh Public Procurement Authority Rule-25 to cancel the bidding process at any time prior to the acceptance of bid(s) or proposal (s). Under following conditions bid will be rejected: -
  - 1. Conditional and telegraphic bids/tenders.
  - 2. Bids not accompanied by bid security of required amount and form.
  - 3. Bids received after specified date and time.
  - 4. Black listed firms.
