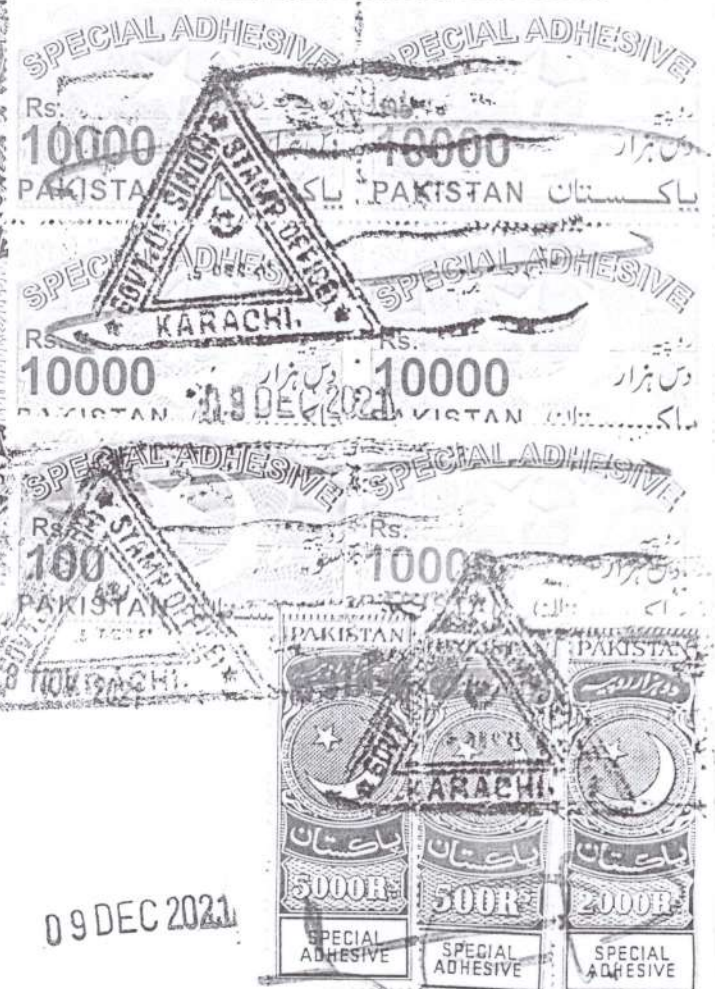

10. Inspection

Inter alia by Inspection Committee of the following:

 - ii. The Deputy Director (Computer), Motor Registration Wing, Karachi; &
 - iii. The Assistant Excise & Taxation Officer/ Incharge Tax Token Stickers, Motor Registration Wing, Karachi
- a. The Committee will inspect the stores on receipt of inspection call from the contractor
 - b. Inspection Committee shall only approve those Tax Token Stickers having the required specification as per tender document including size, colour, thickness
 - c. Inspection Certificate for all approved stores on completion of inspection

11. Packing

Stickers shall be packed in boxes/cartons.

- a. Each packet contain 1000 numbers of Tax Token Stickers
- b. On the front side of stickers, two colours shall be printed. Each colour should be visible from outside
- c. The serial number of stickers should also be readable from outside
- d. The adhesive of the stickers should be permanent in nature
- e. The stickers shall be pasted from inside of the screen of the vehicle and it should be readable from outside

12. Delivery

Cartons containing inspected/approved stores should be dispatched to the Consignee at Motor Registration Wing, Karachi Civic Centre, Karachi (Freight to be paid by the contractor).




Payment will be processed with Accountant General Sindh on submission of the following:
