NO. SO (T-II)/TMTD-109-VIGO/2025:- In exercise of the powers conferred by section 43 of the Provincial Motor Vehicles Ordinance, 1965, the Government of Sindh are pleased to make the following amendments in the Sindh Motor Vehicles Rules, 1969:

AMENDMENTS

In the Fifth Schedule –

- (i) In Serial No. 4 “Registration Fee”, after clause (b), the following shall be inserted: -

“(d-i) Toyota Vigo / Revo / Tundra
and other such double cabin vehicles
above 1500cc **4% of the value of
the vehicle**

- (ii) After serial No. 6, the following shall be inserted:-

“**6-A. Transfer-** Toyota Vigo / Revo
/Tundra and other such double cabin
vehicles above 1500cc **Rs.5000/-**

- (iii) In serial No. 8, the following new entry shall be added:-

“**Alteration / Conversion Fee-**
Toyota Vigo / Revo / /Tundra and
other such double cabin vehicles
above 1500cc **Rs.5000/-**
