SUBJECT **ISSUANCE OF COVER NUMBER PLATES TO GOVT. VEHICLES.**

I am directed to say that during the recent wave of terrorism and subsequent violence many vehicles bearing government number plates have been targeted and damaged. Due to current law & order situation, many departments have approached SGA&CD and Excise & Taxation Department for issuance of cover number plates to the official vehicles.

2. Government of Sindh has finalized the following procedure for issuance of cover number plates which is to be adopted by every department:-

- i) Cover number plates will be issued to all important govt. vehicles on need basis including Local Govt. Autonomous Bodies, District Govt. and Federal Govt. registered with Govt. of Sindh.
- ii) The department is advised to keep the number of vehicles to be issued the cover number plates to bare minimum.
- iii) The Secretary of the Administrative Department/^{Division} will scrutinize the list of vehicles which essentially require the cover number and this will be recommended under his own signature to the Secretary (GA&C) being controlling department and the same will be forwarded to Excise & Taxation Department for the issuance of the cover number.
- iv) Requests for issuance of cover number plates to any govt. vehicle will only be entertained by E&T Department, if it is recommended by GA&CD, Govt. of Sindh.
