NOTIFICATION

NO.SO (T-II)/TMTD-119-Fifth Schedule/2025:- In exercise of the powers conferred by section 43 of the Provincial Motor Vehicles Ordinance, 1965, the Government of Sindh are pleased to make the following amendments in the Sindh Motor Vehicle Rules, 1969:

AMENDMENTS

In the Fifth Schedule –

- (i) In Serial No. 4 “**Registration Fee**”, for clause (e), the following shall be inserted:-

“(e) Vehicles (Trucks/Trailer/Delivery Van/ Mini Buses/Pickups/Vans/Dumpers/Excavators/ Cranes including all other commercial vehicles irrespective of its laden / unladen weight capacity; 0.50% of the value of the vehicle

- (ii) In serial No.6-A,the existing entries shall be renumbered as clause (i) and thereafter the following new entry shall be inserted:-

“(ii) **Transfer of Commercial Vehicles-** Vehicles Rs. 2000/- (Trucks/Trailer/Delivery Van/ Mini Buses / Pickups/Vans/Dumpers/ExcavatorsCranes including all other commercial vehicles irrespective of its laden / unladen weight capacity;

- (iii) In serial No. 8, the existing entries shall be renumbered as clause (i) and thereafter the following new entry shall be added:-

“(ii) **Alteration / Conversion Fee of Commercial Vehicles-** Vehicles (Trucks/Trailer/Delivery Van/Mini Buses/Pickups/Vans/Dumpers/Excavators/Cranes including all other commercial vehicles irrespective of its laden/unladen weight capacity;”.
