In reference to the Administrative Department's earlier communication No.SOIV(Taxes)E,T&NC/02(09)/2025/2192 dated 07th October 2025, the Law Department has opined that the Excise, Taxation & Narcotics Control Department to initiate the proceedings against the defaulters under relevant provisions of Sindh / West Pakistan Entertainment Duty Act, 1958 and the Sindh Professional, Trades, Callings and Employment Tax Rules, 1976, for recovering the outstanding dues OR, in case of failure, initiate litigation against them.

In view of the above, you are hereby advised to formulate and execute a robust and legally tenable strategy for the prompt recovery of outstanding **Professional Tax** and **Entertainment Duty arrears**. Your active collaboration and timely action will be instrumental in ensuring a streamlined and compliant recovery process.
