**NOTIFICATION**

No. SO-IV(Taxes)ET&NC/8-221/ 2024: The Government of Sindh is pleased to notify the following Standard Operating Procedures (SOPs) for the "**Premium Number Plates for Vehicles**" in the Province of Sindh, with immediate effect: -

1. The Premium Number Plates will have the following three categories, available by way of fundraising / collection of donations in an open/online event: -

- i) **Platinum:** Maximum of 3 Characters, any Combination (Alphabets / Numbers)
- ii) **Gold:** Maximum of 5 characters, 1 Alphabet and any combination of upto Four (04) numbers
- iii) **Silver:** Maximum of 7 Characters, Two Alphabets, and any combination of upto Five numbers

## 2. **Schedule for event of fundraising/donation & E-Portal.**

(i) After first introductory event of fundraising / collection of donations, an online portal will be introduced for the registration of offers. All donors will have to deposit an initial non-refundable amount of PKR 10,000/- to participate in the event of fundraising / donations.

(ii) Once the initial donation price / first offered price for a specific Premium Number Plate is published, the public will have seven (7) days to offer a price higher than the initial offered price of the first offered / base price.

(iii) Once the initial offers are received, schedule for an open event of fundraising will be circulated via Website, Online / Social Media platforms and Newspapers, specifying dates, time slots, and available Premium Number Plates.

(iv) The Motor Registration Authority will regularly update the schedule of fundraising events to ensure transparency and fairness.

(v) A user-friendly web-based E-portal will be developed & accessible through the Excise, Taxation & Narcotics Control Department (ET&NCD) website/ App.

(vi) Interested donors can log in, view available Premium Numbers, customize as per their own preferences and participate in these public welfare fundraising events/offering.

## 3. **Application Process.**

(i) Any person/ firm interested in donations via Premium Number Plate shall submit online application through a web portal.

(ii) The donor shall specify his / her preferred category on the portal.

(iii) Pledges can be submitted against any available/proposed Premium Number.

## 4. **Fundraising Event Process.**

(i) After submission of an application, the process will take place either online or on-premises on a specified date & time for each category.

(ii) Prior to this, a committee will review the requests and assess them on merit to determine the appropriateness and decency of the applications for Premium Number Plates. The Committee shall be comprising Additional Secretary as in Chair, Deputy Director (Admin/MVR), Karachi and Deputy Director (Computer) o/o DG E&T as Members.

(iii) During the conduct of fundraising events, donors can place their best / highest pledges against their preferred Premium Numbers. Real-time online tracking ensures transparency throughout the process.



5. **Security Features.** Choice number plates will be incorporated with the following advanced security measures:

**Barcodes:** Enable quick verification by law enforcement agencies.

**Holograms:** Prevent counterfeiting.

**Tamper-Proof Materials:** Deter theft and unauthorized removal.

**Unique Serial Numbers:** Traceable to the owner.

6. **Winner and Payment.**

(i) Successful donor, who pledges highest donations, will be notified via website, email, call or SMS.

(ii) The successful donor shall deposit the offered donations within a specified period of 15 days.

(iii) Non-payment shall result in re-listing of the **Premium Number plate.**

(iv) The **Premium Number** will be associated with the CNIC of the donor.

(v) The allocated number will be **property of the donor** / owner and can be inherited in the event of death of the donor / owner by its legal heir after intimation / permission to and from the department.

7. **Integration with Vehicle Registration System.**

(1) Premium Number Plates will be linked to the donor's CNIC Number in the Motor Registration System.

(2) The Premium Numbers can be assigned / applied on any registered vehicle with prior written intimation by the owner / donor to the Motor Registration Authority, Karachi.

(3) The number is transferable / saleable with prior notice / intimation to the issuing authority i.e. Motor Registration Authority, Karachi and payment of prescribed fee, which is 10% of offered price or as notified by the Excise, Taxation & Narcotics Control Department.

### **Terms and Conditions:**

1. The Premium Number Plates issued under this scheme will be personal property of the donor / owner.
2. These Premium Number Plates can be deployed on any one vehicle after prior intimation to the Motor Registration Authority, Karachi.
3. None of these Premium Number Plates be installed on any unauthorized / Unregistered Vehicles.



4. These Premium Number Plates can be inherited in case of death of owners / donor of the Number after necessary intimation to the Department.
5. In case of lost or stolen Premium Number Plates another Premium Number Plate will be issued on payment of PKR: 5000/- or as notified by the Excise, Taxation & Narcotics Control Department.
6. Premium Number Plates will be transferable to any other person with prior intimation to the issuing authority in written / by email to Deputy Director (Admin/MRA) Karachi after payment of prescribed fee as notified by the Excise, Taxation & Narcotics Control Department.
7. Premium Number Plates will be saleable to anyone with prior intimation to the issuing authority i.e. Deputy Director (Admin/MRA) Karachi in written and after payment of prescribed fee as notified by the Excise, Taxation & Narcotics Control Department.


